1. Tour operator must be registered with UTDB Dehradun
2. Tour operators must have organized treks for at least 500 trekkers in a year

Terms and Conditions

1. The number in a single group of trekkers should not exceed 20.
2. The Tour operator shall attach the copy of the Aadhar card /ID proof of each trekker while registering the details.



3. For the proof of participation of the trekkers in the said trek, The Tour operator shall deposit the copy of the Aadhar Card/ ID proof of the client in UTDB at the time of the claiming subsidy after verifying it by DTDO of the respective District.
4. Group photos from the trek's starting point, en-route camps and halts, and other spots must also be submitted by the Tour Operator.
5. UTDB reserves the right to modify the terms of this scheme at any point at its sole discretion without any right of remedy to the Tour Operators.
6. The Tour Operator shall indemnify UTDB at all times of any expenses of any nature whatsoever including but not limited to medical exigencies, natural calamities, delays and cessation of treks etc.
7. The Tour Operator shall undertake at all times that the trekkers have been screened for medical fitness and have been explained about the trek.

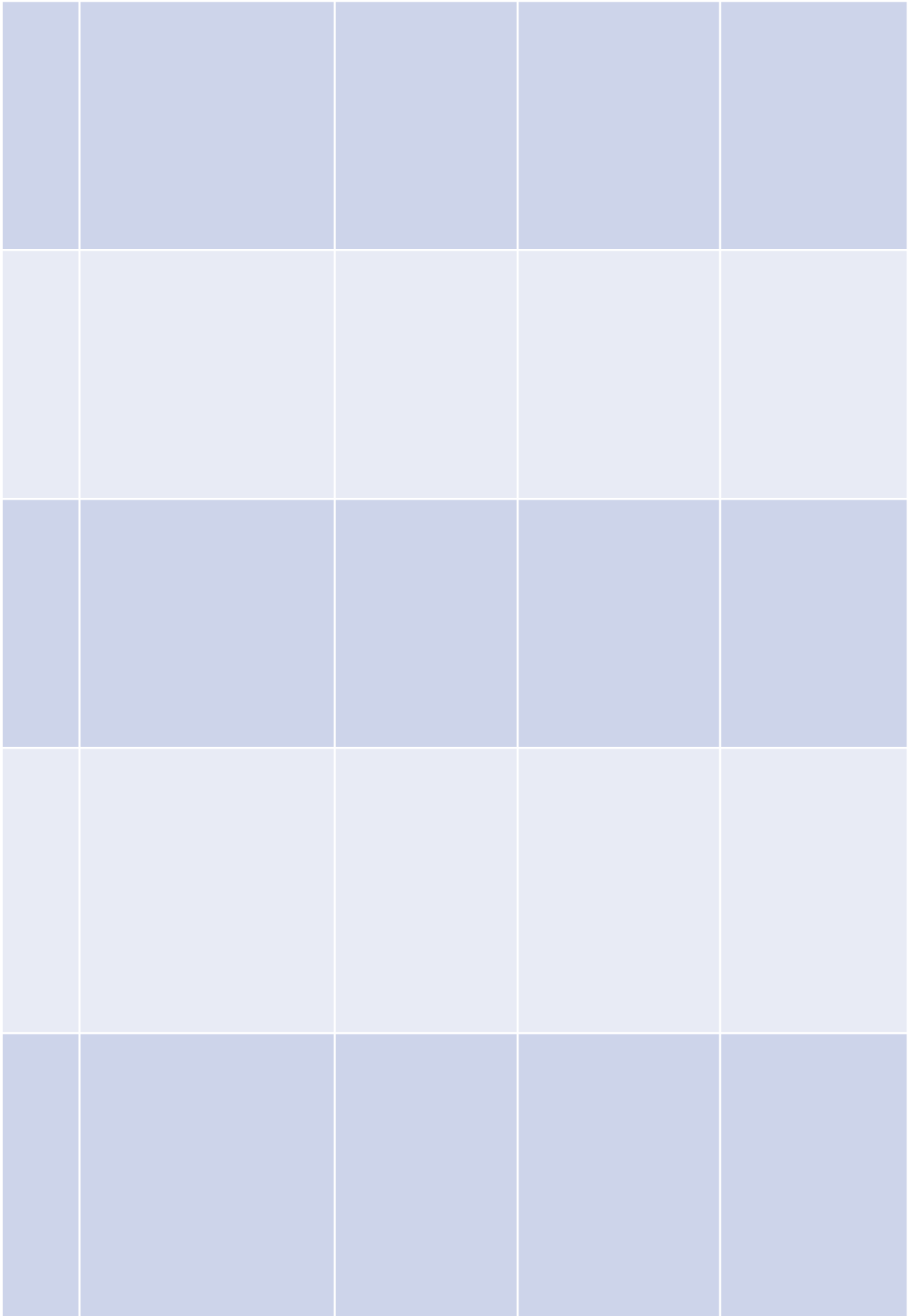

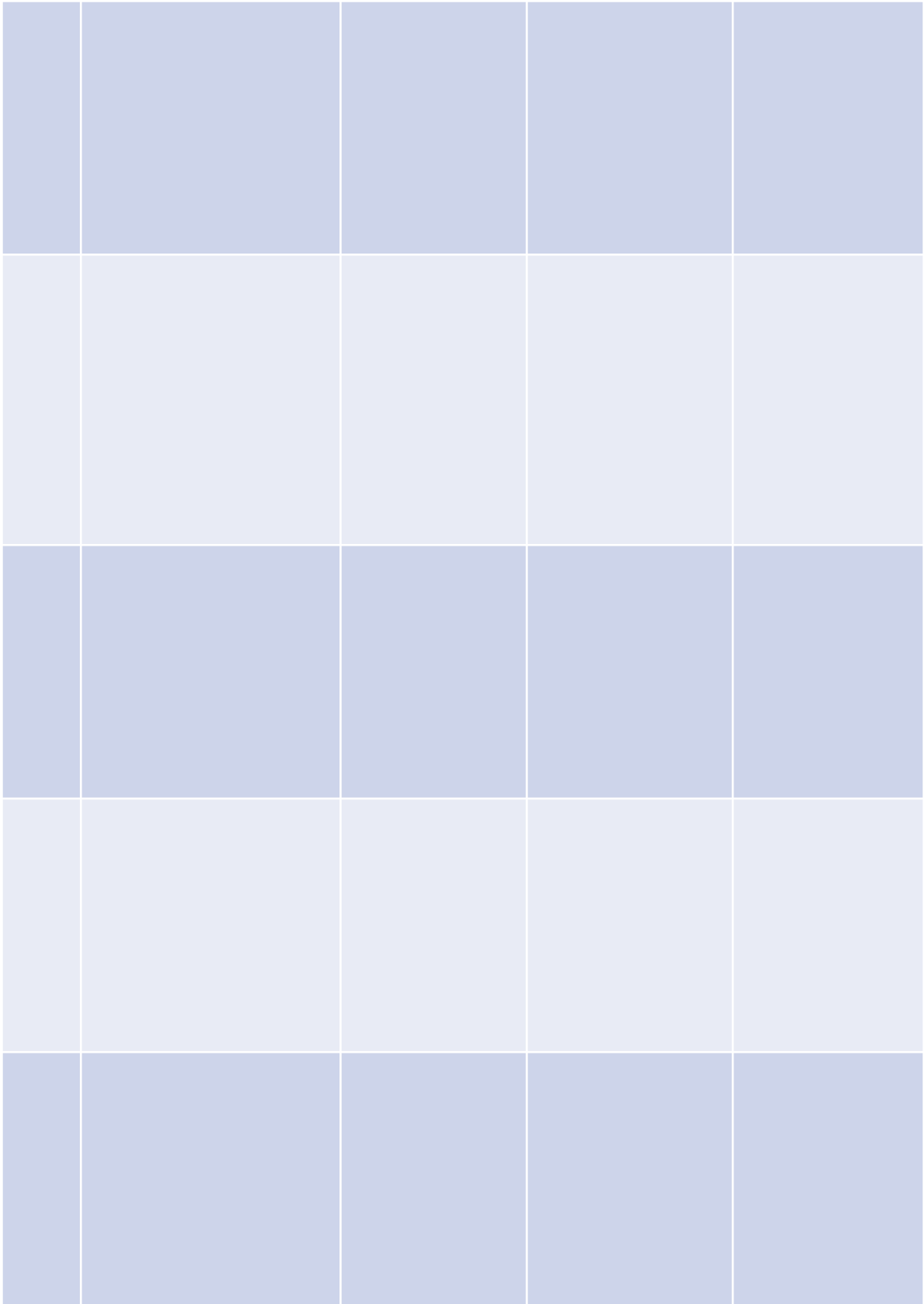
